RULES

- Contestants must be at least 18 years old.
- Each contestant will receive a bag(s) of whole pickled jalapeno peppers 10 per bag.
- You may only eat one pepper during the first minute.
- After 1 minute contestants may then eat as many peppers during the next two (2) minutes, one pepper at a time.
- Peppers must be eaten down to within 1/8 inch of the cap to be counted.
- Contestants will not be allowed any other foods or beverage during the contest.
- Contestants will be disqualified should you be unable to keep peppers down.
- Contestants cannot coat the inside of mouth with any kind of protective coating. Anyone caught will be disqualified.
- The contestant with the most stems after time has been called will be the winner.
- Contestants will be allowed to finish any pepper remaining in mouth when time is called.
- Should there be a tie, contestants will compete in a 30 second competition.
